Dear Parent/Guardian,

The schoolbook rental scheme for **2022/2023** will be available shortly on our Way2Pay school app.

The costs for the book rental scheme next year are outlined as follows:

- **1st Year** €150 (this includes a €50 deposit)
- **2nd Year** €100
- **3rd Year** €100
- **5th Year** €120
- **6th Year** €120

There is no schoolbook fee associated with Transition Year or with the Leaving Certificate Applied programmes of study. The cost for books is included in the cost of the programme fees.

Any students, who have not paid for this year's book rental scheme, may no longer avail of the scheme unless they pay all outstanding balances by the end of this school year.

Students will be charged the full price for any book that is not returned or that is deemed beyond repair, if returned in a poor state. Students will not be allowed back in the scheme until any outstanding balances are paid.

All payments should be made by **Thursday 30th June 2022**. Discounts for families of three or more will be applied through the online payment system.

If payment is not made in full by the date above, we will take it that your child is not availing of the book rental scheme and is making their own arrangements regarding their books.

The full terms and conditions of the scheme are outlined below and if payment is made, it is understood that you have read and accept these terms and conditions.

TERMS & CONDITIONS

1. If full payment for the scheme on behalf of the student is not paid by **Thursday 30th June 2022**, it is accepted that you wish to make alternative arrangements for the purchase of books. **The deadline given is absolute.**
2. The books supplied under the scheme will remain the property of the scheme. They will be subject to inspection at any time by a designated member of staff and/or scheme representative.
3. If books are lost, damaged or not returned, compensation for lost books will be required and your deposit will be forfeit before readmission into the scheme. Normal wear and tear will be considered.
4. Membership of the scheme is at the discretion of the Parents Association Book Scheme Committee.
5. Books supplied under the scheme may be new or second hand at the discretion of the committee.
6. **Admission to the scheme on subsequent years is conditional on the safe return and full payment of all book scheme fees or fines from the previous year/s.**
